
Sir/Madam,

In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Renewal of Recognition of MD(Community Medicine) qualification for 01 seat in respect of students being trained at Dr. Somervell Memorial CSI Medical College & Hospital, Karakonam, Thiruvananthapuram under Kerala University of Health Sciences, Thrissur**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:
