**GENERAL NURSING AND MIDWIFERY COURSE – 2024 ADMISSION**

1. **Management** :C.S.I South Kerala Diocese – South Kerala Medical Mission

2. **Hospital** :Dr. S.M.C.S.I Medical College & Hospital, Karakonam

3. **Philosophy**

Nursing is a profession that provides opportunities for specialization, team work, leadership and personal growth. C.S.I. School of Nursing aims to train, equip, maintain and to up bring the standard of young men and women in the promotion of Physical, Mental, Social and Spiritual health of the people. C.S.I School of Nursing ensures that the teaching and training are in line with the motto “Heal me O Lord”.

4. **History**

The CSI School of Nursing, Karakonam is attached to Dr. Somervell Memorial CSI Medical College and Hospital, Karakonam. The Nursing School buildings were constructed in 1997. The General Nursing and Midwifery Course started in the year 2000 with an intake of 20 students. Now the strength is 40. The total duration of the course is 3 years. The students have to appear for both theory and practical examination conducted by the Kerala Nurses and Midwives Council at the end of each year. All the students are bond to stay in the accommodation provided in the campus. All the students are expected to enroll in the activities of the Student Nurses Association of India. Following the successful completion of training, a certificate in nursing will be issued by the state council which can be registered in the ‘A’ section of the register of Kerala Nurses and Midwives Council. This entitles the nurse to practice as a trained Registered Nurse (RN) and Registered midwife (RM).

## **GENERAL OBJECTIVES OF THE COURSE**

The candidate on completion of this course will be able to:

1. Demonstrate competency in providing health care to individual, sick or well, using nursing process.
  - a. Asses the nursing need of clients from birth to death.
  - b. Plan and carry out appropriate action to meet nursing needs.
  - c. Provide effective nursing care to maintain best possible level of health in all aspects.
  - d. Promote self care in people under their care.
  - e. Apply problem solving techniques in nursing practice.
  - f. Evaluate effectiveness of nursing care.
2. Apply knowledge from the humanities, biological and behavioral sciences in functioning as a nurse.
3. Function effectively with members of the health team and community applying the knowledge of human relations and communication skill in her work.
4. Participate as member of the health team in delivery of curative, preventive, promotive and rehabilitative health care services.
5. Demonstrate use of ethical values in their personal and professional life.
6. Demonstrate interest in activities of professional organization.
7. Recognize the need for continuing education for professional development.
8. Demonstrate basic skills in teaching patients and giving nursing care to them.
9. Demonstrate basic skills in administration and leadership while working with other members of health team and community.
10. Assist in research activities.

## 7. ELIGIBILITY FOR ADMISSION TO GNM COURSE:

### 1. Minimum education eligibility criteria for admission to GNM:

- 10+2 with English and must have obtained a minimum of 40% at the qualifying examination and English individually from any recognized board. Candidates are also eligible from State Open School recognized by State Government and National Institute of Open School (NIOS) recognized by Central Government. However Science is preferable. Three (core elective) subject marks may be taken for calculating the percentage of marks excluding the marks in English. Also, it has to be ensured the candidate has pass marks in English. **Science group with Physics, Chemistry, Biology is preferable.**
- 10+2 with English having 40% of marks in vocational ANM course from the school recognized by Indian Nursing Council.
- 10+2 with English having 40% of marks in Vocational Stream Health care Science from a recognized CBSE board/State/Centre.
- Registered ANM with pass marks.

### 2. For foreign nationals

- The entry qualification equivalency i.e., 12th standard will be obtained by Association of Indian Universities, New Delhi. Institution and SNRC will be responsible to ensure that the qualification and eligibility will be equivalent to what has been prescribed by the Council.

### 3. Reservation Policy

- For disabled candidates: 3% Disability reservation to be considered with a **disability of locomotor** to the tune of 40% to 50% of the lower extremity and other eligibility criteria with regard to age and qualification will be same as prescribed for each nursing program.
- **Note:** A committee to be formed consisting of medical officer authorized by medical board of State government and a nursing expert in the panel which may decide whether the candidates have the disability of locomotor of 40% to 50%.
- 5% of total marks is relaxed for SC/ST candidates.

- Any other reservation as per the State Government.
- 10% supernumerary seats for foreign students shall be reserved. → However, supernumerary seats will be 25% of total seats granted under Section 13 & 14 of INC Act, 1947 for the institutions which have parent hospital of 300 beds or more. This supernumerary quota of foreign students will not be filled by any other quota/general seats.
- **Note:** - Reservations shall be applicable within the sanctioned number of the seats by INC and not prescribed by the Council.

4. Admission of students shall be once in a year.
5. Students shall be medically fit.
6. Minimum age for admission will be 17 years. (as on 31st December of that year). The upper age limit is 35 year. For RANM/for RLHV there is no age bar.

#### **8. DURATION OF THE COURSE:**

Duration of the Diploma Course in General nursing and Midwifery shall be 3 years. The maximum period allowed to complete General Nursing and Midwifery Course is 6 years.

#### **9. SYLLABUS:**

Syllabus of the course shall be the revised General Nursing Midwifery Syllabus 2015 of the Indian Nursing Council.

#### **10. NO. OF SEATS:**

The total number of the seats to General Nursing and Midwifery Course is 40

#### **11. APPLICATION FORM:**

##### **How to apply to submit the application form**

##### **Phase I- Registration**

1. Visit the website of the Dr. SMCSI Medical College & hospital.  
([www.smcsimch.ac.in](http://www.smcsimch.ac.in))
2. Click on the link GNM
3. The application Registration fee Rs. 500- for General Nursing and Midwifery programme shall be paid through the online gateway payment.

4. The details of the remittance is to be entered in the Application form as otherwise the Application will not be accepted
5. Click on the New Applicants Registration
6. Enter correct details in all the columns of the Application form.
7. Note down the email id and date of birth entered for future reference
8. Click the “Submit” Button.
9. Your application ID will be displayed and also e-mailed to you in the e-mail id provided by you, which should be noted down for future reference.

### **Phase II- Registration**

1. Click “Candidate Registration” for commencing processing of the application.
2. Type in the email ID and date of birth to Log in. the entire Application form together with the data you have filled in will reappear for your verification and correction ( if any) for physically registering the application with the college.
3. Upload passport size photo, 10<sup>th</sup>, plus two certificate and signature of parent & candidate.
4. Once you are satisfied with the entries, press confirms.
5. At this stage the information in the application form will be frozen. No further chances will be possible.
6. Now the application from, the downloaded page will be displayed.
7. Log out to complete the online process.

### **Phase III – Application Form to CSI School of Nursing Karakonam**

1. Please login using your email-Id and date of birth, then download application form from your computer for self check.
2. Include the payment receipt also ( DD/ online payment)
3. Applications submitted should be completely in all respects. In complete applications will stand rejected. Application will not be allowed to include any information in the application form, nor submit any certificates/ documents later.

## **12. DOCUMENTS TO BE SUBMITTED ALONG WITH THE APPLICATION ARE:**

- (a) Self attested copy of the relevant page of S.S.L.C or Equivalent certificate to prove the date of birth.
- (b) Self attested copies of Mark lists of all parts of Higher Secondary or equivalent Examination and pass certificate in the qualifying examination.
- (c) Equivalency certificate from Higher Secondary Board, Kerala, for candidates who have completed qualifying examination from outside Kerala state.
- (d) For foreign nationals, the entry qualification equivalency i.e., 12<sup>th</sup> standard can be obtained from Association of Indian Universities, New Delhi.
- (e) Copy of recent Conduct Certificates (not prior to six months) from the Head of the Institution in which the candidate studied last.
- (f) Caste and income certificate from Village officer/ Tahsildar if the candidate is to be considered under any reservation seat (SC/ST, OBC). There is no need for income certificate for SC/ST candidates.

## **13. MODE OF ADMISSION:**

Admission to Diploma in General nursing and Midwifery will be made on merit as assessed on the basis of the total marks secured by the candidates for the Part III optional subjects at the Plus two examination/equivalent examination. Science group with Physics, Chemistry, and Biology is preferable. In the absence of candidates with science group, candidates with other groups also will be considered. If there is a tie in the total marks in the optional subjects, the candidate with higher marks in English at the +2/equivalent examination will be ranked higher. In case there is still a tie, the candidate with higher total aggregate marks in +2/equivalent examination will be ranked higher. If there is still a tie, the rank will be decided on the basis of date of birth, i.e., the elder person will be ranked higher.

## **14. SELECTION**

Candidates will be called for interview and certificate verification by Selection Committee and select list will be prepared by the Committee. Candidates should produce original certificates and documents for verification at the time of interview.

## **THE SELECTION COMMITTEE WILL CONSIST OF**

- (1) Council Nominee
- (2) Director of the institution
- (3) Medical Superintendent
- (4) Nursing Superintendent
- (5) Principal of the School of Nursing

The select list will be published by the Principal, School of Nursing after the interview.

### **15. ANTI – RAGGING**

According to the Kerala Prohibition of Ragging Act. 1998, 'ragging' means doing of any act by disorderly conduct to a student of an educational institution, which causes or is likely to cause physical or psychological harm or raising apprehension or shame or embarrassment to student and includes teasing or abusing or playing practical jokes or causing hurt to such students or asking a student to do any act or to perform something which such students will not in the ordinary course be willing to do. All institutions will have to abide by the directives of the Honorable Supreme Court of India. Dated May 16, 2007 in SLP No. (S) 24295 of 2006 University of Kerala vs. Council Principal's Colleges, Kerala & Ors. (with SLPI No. 24296- 99/2004 and WP (Crl.) No. 173/2006 & SLP I No.14356/2005] and the recommendations approved by the Honorable Supreme Court of India on effective prevention of ragging in educational institutions. In case the applicant for admission is found to have indulged in ragging in the past or if it is noticed later he/she shall be expelled from the educational institutions. Each of the student of the institution and his/her parents or guardian are required to submit a combined, undertaking at the time of registration/admission in prescribed format available in Annexure II which is mandatory for registration/admission.

### **16. CONCESSION**

Selected candidates are eligible for educational concession/scholarship/ grants/admissible for SC/ST/OEC candidates.

**17.** Hostel facility will be provided to candidates, if required.

**18.** Students are liable to undergo GNM course and its syllabus as stipulated by Indian Nursing Council.
