
Subject: Continuation of Recognition of MBBS degree (150 seats) granted by Kerala University of Health Sciences, Thrissur in respect of the students being trained at Dr. Somervell Memorial CSI Hospital & Medical College, Karakonam, Thiruvananthapuram.

Sir,

In exercise of the powers conferred by Sections 24(j) and 35(4) of NMC Act, 2019, the approval of the UGMEB, NMC is hereby conveyed for grant of *Continuation of Recognition of MBBS degree granted on or after January, 2023 by Kerala University of Health Sciences, Thrissur in respect of the students being trained at Dr. Somervell Memorial CSI Hospital & Medical College, Karakonam, Thiruvananthapuram* with sanctioned annual intake of 150 MBBS students under the following terms & conditions, as contained in the Gazette Notification No. MCI- 34(41)/2010-Med./3491, dated 16th April, 2010 titled "Establishment of Medical College Regulations, (Amendment), 2010:

- (i) *The recognition so being granted herein, shall be valid for a maximum period of 05 (five) years from the date of issue, upon which it shall have to be renewed.*
- (ii) *The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.*
- (iii) *Failure to seek timely renewal of recognition as required in sub-clause (i) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute.*

2. This approval for Continuation of Recognition (150 seats) is granted subject to applicability of amendments in MCI/NMC Regulations from time to time.
