3. The College will maintain the Community Health Centre and Primary Health Centre, make necessary additions after getting necessary clearance from Government. The Director of Health Services would be consulted before effecting any improvement/addition.

4. Add on necessary laboratory equipments and arrange for upkeep of the

existing once:

5. Fee for each student (to be determined by the DHS) will be paid into the account of Hospital Development Committee of these hospitals. The amount thus collected would be spend for the development of the hospital. 🦠

6. The electricity and water charges of the hospitals will be paid by the College.

 The running of the centres will continue to be vested with the Director of Health Services and his field level officers.

As per Government Order read as Ist paper above, permission was granted to Dr. Somervell Memorial C.S.I Hospital& Medical College, Karakonam, Thiruvananthapuram to make use of the facilities of community Health Centre, Vellarada and Primary Health Centre, Kunnathukal for the study purpose of the medical students of the Dr. Somervell Memorial C.S.I. Hospital & Medical College, Karakonam subject to certain conditions. It was also specified therein that fee as fixed by the Government would be collected by the College and the fee for each students (to be determined by the Director of Health Services) would be paid into the account of the Hospital Development Committee of these hospitals and the amount collected would be spent for the development of the hospital.

The Director of Health Services in the letter read above has suggested to collect fee at the rate of k: 1500/- for each medical student and k: 1000/- for each B.Sc Nursing student for the above training.

The Government have examined the case and have accepted the proposal. Accordingly the fee for each medical student and for each B.Sc Nursing student of the Dr.Somervell Memorial C.S.I Hospital & Medical college Karakonam for the training at the community Health Centre, Vellarada and Public Health Centre, Kunnathukal is fixed @ ks: 1500/- (Rupees One thousand five hundred only) and ks: 1000/- (Rupees One thousand only) respectively
