ORDER

University vide paper read (1) above, invited applications for continuation of provisional affiliation for the academic year 2019-20 from colleges for courses affiliated to the University. The Principal, Dr. Somervell Memorial CSI Medical College, Karakonam-MM005 vide paper read (2) above has submitted application for the continuation of provisional affiliation for the year 2019-20.

2. On verification of the application it is found that the college has submitted necessary documents and remitted fee for continuation of provisional affiliation for the year 2019-20. The inspection commission vide paper read (3) above, has submitted report after conducting inspection at the College. The Scrutiny Committee, vide paper read (4) above, after verifying the inspection report has pointed out deficiencies of faculties and recommended to conduct a surprise re-inspection on receipt of compliance report from the college after rectification of the deficiencies noted during the inspection. The Principal has submitted the compliance report claiming that they have rectified the deficiencies. The inspection commission vide paper read (5) above, has submitted report after conducting reinspection at the College. The Scrutiny Committee, vide paper read (6) above, after verifying the inspection report has recommended to inform the College to urgently rectify the deficiencies noted in the reinspection. The matter was placed before Sub Committee meeting of the Governing Council held on 03/07/2019 and the committee recommended to grant conditional continuation of provisional affiliation to Dr Somervell Memorial CSI Medical College, Karakonam-MM005 for the academic year 2019-20 on condition that College should rectify the faculty deficiency and such rectification will be verified in the next surprise inspection. As per paper read (8) above, MCI has decided not to permit the College to admit any students for increased seats from 100 to 150. The decision of sub committee of Governing Council was placed before 55th Governing Council meeting held on 15/07/2019 and Governing Council vide paper read (9) above, has approved and ratified the decision of Sub Committee meeting held on 03/07/2019.



3. Sanction, has therefore been accorded by the Hon'ble Vice-Chancellor by implementing the Governing Council decision No.55.33 to grant conditional continuation of provisional affiliation to Dr. Somervell Memorial CSI Medical College, Karakonam-MM005 for conducting the following courses with an annual intake of students mentioned against each during the academic year 2019-20 subject to the conditions detailed below:-

- 1 The college shall rectify the deficiency of one Associate Professor in Biochemistry, two Associate Professor in Pathology, one Associate Professor and One Assistant Professor in Forensic Medicine, one Associate Professor in Community Medicine, one Associate Professor in General Medicine, one Senior Resident in Respiratory Medicine, one Assistant Professor in Psychiatry, one Assistant Professor in OBG, one Assistant Professor in Anaesthesiology and one Assistant Professor in Radiodiagnosis and the compliance report should be submitted to the University within 30 days.

Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.

- 2 In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- 3 Affiliation granted is strictly provisional and only for the academic year 2019-20. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- 4 The College should remit annual administration fee fixed for UG/PG course for the academic year 2019-20.
- 5 Admission to the next academic year shall be made only after obtaining prior permission from the University.
