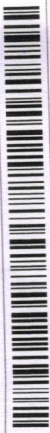

**ORDER**

1. University vide paper read (1) above, invited applications for Continuation of Provisional Affiliation for the academic year 2022-23 from the colleges for courses affiliated to this University. The Principal, Dr.Somervell Memorial CSI Medical College,Karakonam,Thiruvananthapuram-MM005 has submitted applications for the continuation of provisional affiliation for the academic year 2022-23 vide paper read (2) above.
2. On verification of the applications, it is found that the college has submitted necessary documents for continuation of provisional affiliation for the year 2022-23.The inspection commission vide paper read (3) above, has submitted the inspection report after conducting inspection at the college.The Scrutiny Committee, vide paper read (4) above, after verifying the inspection report, the Scrutiny Committee pointed out the faculty and Resident deficiencies and CoPA may be recommended however the deficiencies have to be rectified.These deficiencies were intimated to the college vide paper read (5) above. Accordingly the college submitted a compliance report vide paper read (6) above.After scrutinizing the compliance report, the Scrutiny Committee has recommended CoPA to Dr.Somervell Memorial CSI Medical College,Karakonam,Thiruvananthapuram for the academic year 2022-23 vide paper read (7) above.Considering this name of the college have been intimated to the CEE as the allotment process was already on.
3. Vide paper read (8) above, the National Medical Commission has decided to permit to grant the recognition and continuation of recognition for MBBS course for the year 2022-23 to those colleges whose recognition and continuation of recognition are in due.**The matter has been placed before the 72nd meeting of the Governing Council held on 27.12.2022 and the GC vide decision No. 72.05 has resolved to ratify the action of the Hon'ble VC in having granted Continuation of Provisional Affiliation to Dr.Somervell Memorial CSI Medical College,Karakonam,Thiruvananthapuram for the academic year 2022-23 and forwarding the same to DME/CEE vide paper read (9) above.**





4. Accordingly, orders are issued granting sanction for the Continuation of Provisional Affiliation to Dr.Somervell Memorial CSI Medical College,Karakonam,Thiruvananthapuram for conducting the following course with an annual intake of students mentioned against each during the academic year 2022-23 subject to the conditions detailed below:-

- Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- Affiliation granted is strictly provisional and only for the academic year 2022-23. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- The College should remit annual administration fee fixed for UG/PG course for the academic year 2022-23.The College shall produce the orders regarding the constitution of College Council for the academic year 2022-23 during the time of student data verification.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
