ORDER

As per paper read (1) above applications were invited for continuation of provisional affiliation for the academic year 2018-19 from colleges for courses affiliated to the University. The Principal, Dr. Somervell Memorial CSI Medical College, Karakonam-MM005 vide paper read (2) above has submitted applications for the continuation of provisional affiliation for the year 2018-19.

2) On verification of the applications it is found that the College has submitted necessary documents and remitted required fee for continuation of provisional affiliation for the year 2018-19. Inspection was conducted at the College and the inspection report was submitted vide paper read (3) above. The Scrutiny Committee vide paper read (4) above, after verifying the inspection report, has pointed out deficiencies of faculties. The College, vide paper read (5) above, has submitted Compliance report. The Scrutiny Committee vide paper read (6) above verified the compliance report submitted by the college and recommended to grant continuation of provisional affiliation to the College. The Ministry of Health and Family Welfare, Govt of India vide paper read (7) above has denied the renewal permission for increased seats of MBBS from 100 to 150. The College has submitted documents of constitution of College Council for the year 2018-19. The Ministry of Health and Family Welfare, Govt of India vide paper read (8) above has granted renewal recognition for 100 MBBS seats to the college. The Governing Council vide paper read (9) and (10) above has decided to grant Continuation of provisional affiliation to Dr. Somervell Memorial CSI Medical College, Karakonam for the year 2018-19.

3) Sanction, has therefore been accorded by the Vice-Chancellor by implementing the Governing Council Decision 47.32 (a) and 48.43 to grant continuation of provisional affiliation to Dr. Somervell

- 1 The deficiency of Professor in the Dept of Pulmonary Medicine should be rectified within one month under intimation to the University.
.Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- 2 In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- 3 . Affiliation granted is strictly provisional and only for the academic year 2018-19. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- 4 .The College should remit annual administration fee fixed for UG/PG course for the academic year 2018-19
- 5 Admission to the next academic year shall be made only after obtaining prior permission from the University.
