This is in continuation to erstwhile Medical Council of India letter No.MCI-37(1)(RI-14)/2019-Med./ 63, dated 24.09.2020 for renewal of permission for admission of 5<sup>th</sup> batch of MBBS students against the increased intake i.e. from 100 to 150 seats at Dr. Somervell Memorial CSI Medical College, Thiruvananthapuram, submitted u/s 10A of the IMC Act, 1956 to now dissolved Board of Governors in Supersession of the Medical Council of India. 2. Accordingly your application was processed u/s 10A of the IMC Act, 1956 and the Opening of a New Higher Course of Study or Training (including Post-graduate Course of Study or Training) and Increase of Admission capacity in any Course of study or Training (including Post-graduate Courses of Study or Training) Regulations, 2000. I am directed to convey the permission of the Medical Assessment and Rating Board of the National Medical Commission for renewal of permission for admission of 5<sup>th</sup> batch of MBBS students against the increased intake i.e. from 100 to 150 at Dr. Somervell Memorial CSI Medical College, Thiruvananthapuram u/s 28 read with section 61(2) of NMC Act, 2019 for the academic year 2020-21.
