## ORDER

As per paper read (1) above, the University had invited applications for Continuation of provisional affiliation for the academic year 2017-18 from colleges for courses affiliated to this University. The Principal, Dr. Somervell Memorial CSI Medical College, Karakonam-MM005 has submitted application for the Continuation of provisional affiliation for the year 2017-18 vide paper read (2) above.

On verification of the applications it is found that the college has submitted necessary documents and they have remitted necessary fee for Continuation of provisional affiliation. The report submitted by the Inspection Commission vide paper read (3) above was scrutinized by the Scrutiny Committee. The Scrutiny Committee after verification of Inspection report vide paper read (4) above recommended to intimate the deficiencies to the college to get compliance report and to grant Conditional Continuation of provisional affiliation to Dr. Somervell Memorial C.S.I Medical College & Hospital for the academic year 2017-18. As per paper read (5) above the college has submitted the compliance report. The Scrutiny Committee has scrutinized the compliance report vide paper read (6) above and recommended to grant Continuation of provisional affiliation. The college has obtained recognition/renewal permission for the UG/PG Medical degree courses for the academic year 2017-18.

Sanction has been accorded by the Hon'ble Vice Chancellor by exercising the powers conferred under section 12(7) of Kerala University of Health Sciences Act, 2010 to grant Continuation of provisional affiliation to Dr. Somervell Memorial CSI Medical College, Karakonam-MM005 for conducting the following courses with an annual intake of students mentioned against each during the academic year 2017-18, subject to the ratification of Governing Council and the conditions detailed below:-

1. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
2. In the light of the direction of the Supreme Court of India in Writ Petition (C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
3. Affiliation granted is strictly provisional and only for the academic year 2017-18. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
4. The College should remit annual administration fee fixed for UG/PG course for the academic year 2017-18.
5. Admission to the next academic year shall be made only after obtaining prior permission from the University.
